


## Statement of Declaration

I, Brandie L Burr declare the following:


- I have known Lisa to be a hard working, goal oriented individual even through her struggles of addiction and domestic abuse, following the death of her son.
- Her marriage to my uncle, Scott Badders was riddled with strong elements of power and control (including drug addiction) which inevitably led to physical abuse. I was often a support to Lisa following instances of the physical abuse, including taking her to the hospital for treatment for her injuries.
- In 1997, I learned that Lisa could obtain methamphetamines from a source in California and introduced her to my daughter's father, Shawn Haller who had interest in this connection for his profit. She agreed to purchase meth- amphetamines from this supplier for Shawn to limit her expense for her own drug use.
- Lisa's involvement in the conspiracy for which she was convicted, to my knowledge, was as a connection for her own use that was extorted by others for their gain and in no way was that of a "king pin or ring leader."
- As I understand from my involvement, Scott took control of the purchase and distribution of methamphetamine and Lisa was involved VERY little in this practice after November of 1997. Making few purchases from her "source" after this time, for her use or otherwise.
- The "Report of Investigation" reports that I stated that Lisa "has moved one pound or more of pure methamphetamine a week for a year and a half". I have no knowledge of the amounts of methamphetamine that were "moved" for the time span mentioned, as my involvement in said conspiracy was intermittent and non-existent after March or April of 1998, less than a year after finding out about Lisa's "connection" and introducing her to Shawn Haller.
- I continued to have contact with Scott Badders, Doug Harper and rarely Shawn Haller through November 1998: however, I was no longer privy to the details of their drug trafficking operation, because it was believed that I could not be trusted. I have no knowledge of any "business" that was conducted from March or April of 1998 to November of 1998 although I was still using. I also had limited information regarding what was "moved" from August of 1997 to March or April 1998, although there were times I was involved.
- To further support the inaccuracy of the Report of Investigation, I declare that I have no knowledge of several names mentioned in said statement, including, Mark Endsley and Gary Massey. The statement also states that I met a man named Chuck at Lisa's home, this is also untrue.
- The amounts of methamphetamine said to be distributed by me in this statement are also distorted. My involvement in the established drug trafficking conspiracy was limited, as was my knowledge of quantities of the drug or the money obtained through its sales.

I do herby swear under the law of the United States that the information in this declaration is true and correct to the best of my knowledge and recollection.
